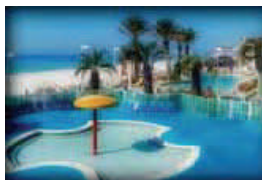

AMATEUR ATHLETIC WAIVER AND RELEASE OF LIABILITY

READ BEFORE SIGNING

In consideration of being allowed to participate in any way in the Snapper Bowl Classic athletic sports program, related events and activities, Panama City Beach Fl. the undersigned acknowledges, appreciates and agrees that:

1. The risk of injury from the activities involved in this program is significant, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,

Please ensure all players have the necessary equipment to compete. All players MUST have a mouth piece which attaches to the helmet facemask. Failure to have the proper equipment will result in a player being ineligible to compete in the tournament. Also, **steel tipped /screw-in cleats are NOT allowed**. Teams are not matched for competition by Average Weight and Age. To be the Best Team you must play all Teams within your Bracket. Players that exceed Ball Carrier Max weight, will be marked by a strip of Tape across their helmet. If wearing white Helmets, Tape will be placed in clear View of the officials and opposing Coaches.

Responsibilities For:

Head Coaches:

1. Are responsible for the conduct of all coaches, players, parents and spectators on their sidelines.
2. Have all paperwork, birth certificates, etc. ready for check-in. Players should be in Numerical order with Jersey's On.
3. Are responsible for having there team at the field Thirty (30) minutes before scheduled Game.

Trip Manager:

1. Responsible For teams to check-in with SnapperBowl Official no later then 5:00pm on Wednesday November 23rd, for weigh-in, Individual / Team Pictures and Birth Certificate Check. Team Check-ins will be very busy. The earlier you can check-in, the less wait time you will have.
2. Responsible for all Contact Information on and off the Field of Play. Contact numbers of SnapperBowl officials, Field Representatives, schedule, map and any other information needed at time of Check-in with SnapperBowl Officials.
3. Will coordinate all information to there respective team parents, players and Coaches.
4. Should you need any assistance, on or off the field, Only the Head Coach or Trip Manager shall make contact with a SnapperBowl officials, and/or Field Representatives.
5. Responsible For all Documents ie: Birth Certificates, Rosters, Insurance Forms, Release of Waivers, and Signed Notarized Forms.

SnapperBowl Rules

This package contains the forms, rules and procedures which must be adhered to for teams participating in the SnapperBowl Classic (hereafter referred to as "Tournament"). The Tournament will be placed under the Florida State High School Associations of America (FHSAA), and (NFHS) National Federation of High School Tournament Rules are for game competition. Your league may have rules regarding post season competition which may or may not be superseded by FHSAA & NFHS Tournament Rules. Specified SnapperBowl Rules will superseded FHSAA & NFHS Tournament Rules. The Head Coach of each team participating in the SnapperBowl is ultimately responsible for all records keeping, team finances and conduct of all participants (including parents, spectators, etc.) attending the tournament. You may assign a Team Manager to assist with the coordination, communications and records keeping of your team. However, having a Trip Manager does not relieve the Head Coach as the final responsible party. Due to the number of players, coaches and parents expected to attend, we must limit the authority to contact the SnapperBowl Tournament to ONLY One (1) Head Coaches and/or the Team Manager.

The tournament will not accept phone calls from Parents. Parents must contact the Head Coach, who in turn, may contact the tournament for additional information.

All documents submitted to the Tournament must be notarized. This includes your League 'Roster.

Failure to have the Tournament documents notarized will prevent your team's acceptance into the tournament. All team documents must be returned to the SnapperBowl no later than November 15.

Acceptance of SnapperBowl Rules, Terms and Conditions

I have read and understand the rules and terms of SnapperBowl Classic regarding my/our team's participation in the Tournament. I understand that all teams participating in the Tournament must arrive in Panama City Beach Fl. no later than Wednesday (Day prior to start of tournament). I further understand that failure to arrive in sufficient time to allow the tournament administrators to verify player ages, weights and team documentation may result in the team's disqualification from the tournament. I understand that the SnapperBowl Classic begins on Thanksgiving Day and continues until Saturday.

I have discussed the rules and expectations of proper conduct with all Tournament participants, including but not limited to Coaches, Players, Parents and other spectators who may be attending as representatives of my/our team. All persons representing my/our team understand, have accepted and will abide by the SnapperBowl rules.
